The Odisha Staff Selection Commission (OSSC), Bhubaneswar has sponsored **Sri Sriram Panda PWD(LV), OSSC Sl. No.130** vide their Notification No.IIE (Conf)-67-2022-180(c) OSSC, dtd.03.09.2022 and communicated vide letter No.5615/OSSC, dtd.06.09.2022 for appointment as "Initial Appointee" in the post of Junior Assistant of D.G.P.O. Cadre on contractual basis as per the Odisha Group-"C" & Group-"D" posts (Contractual Appointment) Rules, 2013 read with GA & PG Deptt. Notification No.28621/Gen., dtd.27.10.2021 and also instructed that the appointment order in respect of the selected candidates under PWD category shall be issued after confirmation of genuineness of their disability from the **Appellate Medical Board** as per provision under Clause-2(3) of the Department of SSEPD, Odisha Resolution No.1843/SSEPD, dtd.25.02.2021. Accordingly, DMET, Bhubaneswar, SCBMCH, Cuttack and SSEPD, Bhubaneswar were requested to furnish the confirmation about genuineness of disability as per provision under Clause-2(3) of the Department of SSEPD, Odisha Resolution No.1843/SSEPD, dtd.25.02.2021 in respect of above selected 2(two) persons under PWD category. In response, Govt. vide SSEPD, Bhubaneswar letter No.9214/SSEPD, dtd.06.12.2022 has intimated that Sri Sriram Panda, PWD in Visual impairment (Low Vision) can be employed as Junior Assistant.


In the meantime, Government of Odisha has been pleased to make the Odisha Group "B", "C" and Group "D" posts (Repeal and Special Provisions) Rules, 2022 issued vide G.A. & P.G. Department Notification No. 29076/Gen., dtd. 16.10.2022 and published in Odisha Gazette No.2946, dtd.16.10.2022 to repeal the Odisha Group-B posts (Contractual Appointment) Rules, 2013 and the Odisha Group-"C" and Group-D posts (Contractual Appointment) Rules, 2013 and to provide special provisions to regulate the services of the employees appointed on contractual basis under the said rules.

Hence, Sri Sriram Panda is hereby appointed as **Junior Assistant in DGPO Cadre on regular basis** as per the Odisha Group "B", "C" and Group "D" posts (Repeal and Special Provisions) Rules, 2022 in the Pay Band of Rs.5200-20200/- with Grade Pay of Rs. 1900/- with usual DA and other allowances as admissible from time to time as per ORSP Rules, 2017 with effect from the date of his joining. His appointment is subject to satisfactory verification of original certificates regarding age, caste/category, educational qualification etc. In case, any information /certificates submitted by the candidate is established to be false or incorrect at any stage, his service will be terminated forthwith in accordance with the provisions laid down vide clause (h) of explanation under Rule-13 of Orissa Civil Service (Classification, Control and Appeal) Rules, 1962.

His appointment is purely temporary and can be terminated at any time without notice or assigning any reason thereof. He shall be on probation for a period of two years which shall be counted from the date of joining the post.

On such appointment, he is directed to report his joining at Office of **I.G. of Police, Central Range, Cuttack on 29.12.2022 positively**. If he fails to join on the said date without assigning any satisfactory reason, his appointment shall stand cancelled.
