OFFICE ORDER NO. 1323 /Pers.-II dtd. 09.08.2023

The case of S.I. of Police (Armed) Saktikanta Naik (Sl. No.01 of CSB-2023) of Angul district was placed before the Central Selection Board-2023 held at State Police Hdqrs., Cuttack on 07.07.2023 for consideration of his promotion to the rank of Inspector of Police (Armed) but the findings of the CSB regarding his promotion was kept in individual sealed cover as Sundargarh Town P.S. Case No.217 dtd.15.12.2014 U/s 341/332/294/426 IPC was pending against him. In the meantime, he was acquitted from the charges leveled against him in G.R. case No.1145 of 2014 arising out of Sundargarh Town P.S. Case No.217 dtd.15.12.2014 U/s 341/332/294/426 IPC by the Hon'ble Court of SDJM, Sundargarh vide its Order dtd.31.08.2016. Thereafter, S.I. of Police (Armed) Saktikanta Naik has appeared in grievance dtd.17.07.2023 for consideration of his retrospective promotion to the rank of Inspector of Police (Armed) from the year-2023. The matter was examined and placed before the DGP. As per orders of the DGP the sealed cover containing the findings of the CSB for the year-2023 in respect of S.I. of Police (Armed) Saktikanta Naik of Angul district was opened on 03.08.2023 and found that he has been selected by the CSB for the year-2023 held on 07.07.2023.


Sri Saktikanta Naik (S.T.) S.I. of Police (Armed) of Angul district is allowed promotion to the rank of Inspector of Police (Armed) retrospectively with effect from the date of his junior Ex- S.I. of Police (Armed) Sri Lingaraj Majhi (S.T.) (Sl. No.03 of 2023) was allowed promotion to the rank of Inspector of Police (Armed) vide State Police Hdqrs. Office Order No. 1037/Pers.-II dtd.14.07.2023. Accordingly, his seniority in the rank of Inspector of Police (Armed) is fixed above Ex- S.I. of Police (Armed) Sri Lingaraj Majhi (S.T.).

His pay will be fixed notionally in the time scale of pay of Inspector of Police (Armed) from the date of his immediate junior was allowed promotion to the rank of Inspector of Police (Armed). He is not entitled to any financial benefits for the period he has not actually worked in the higher grade/post.

His posting will be decided by the "Transfer Committee Meeting".

This issues with the approval of DGP.
