OFFICE ORDER No. 1399 /Pers-I, **Dated:-** 12 / 09 / 2023

Having been selected by the Cadre Change Board constituted under Rule 7 of Appendix-A of the Odisha Police Service (Method of Recruitment and Conditions of Service) order, 2021 notified vide Home Department Notification No.31202/D&A dtd. 04.09.2021 held on 12.09.2023, following 49 Nos. of Constables of different districts (Parent Cadre) are absorbed in districts as mentioned against each for the year – 2023 on consideration of their applications as per the terms and conditions laid down under Appendix-A of the Home Department Notification No.31202/D&A Dtd. 04.09.2021.

As per the undertaking submitted by the Constables, they will lose their seniority of parent cadre and their seniority in the Districts they are absorbed will be counted from the dates of their absorption in new cadre. Qualifying service required for promotion to the Rank of Havildar and ASI of Police will be counted from the dates of their absorption in districts they are absorbed. Any test they would have passed in previous (Parent) Districts will not be counted for their promotion to the rank of Havildar.
