OFFICE ORDER NO. 187 /Pers. II., Dt. 10 -03.2021.

Government vide their Order No.34053/DA1, dated.16.10.2020 have relaxed the eligibility criteria for redeployment of Sepoys of OSAP 1stSS Bn., Sambalpur and OSAP 2nd SS Battalion, Keonjhar to District/Establishments. The matter was agitated in the Hon'ble High Court in W.P. (C) No.29302 of 2020. In accordance with the Order of the Hon'ble High Court dated 24.02.2021, State Police Headquarters have issued Office Order No.173/Pers.-II, dated.26.02.2021 ordering redeployment of 1093 Sepoys from OSAP 1stSS Bn., Sambalpur and OSAP 2nd SS Battalion, Keonjhar to different Districts/ Establishments.


It has been brought to the notice of State Police Headquarters that out of 1093 the following numbers are on deputation to other Organization as noted (1st SS Bn. – 16 in SOG, 2nd SS Bn. 47 in SOG + 1 in SIW). A clarification has been sought.

After examining all relevant facts and circumstances of the matter, it is decided as follows:-

1. Those on deputation to Police Establishments will be allowed to complete their tenure of deputation in their deputed Organization (SIW, SOG) as noted against each.
2. However, they will be relieved by the Organization, where they are on deputation, to go and join in the district to which they are redeployed. They will join in such district without availing any joining time.
3. The district will accept their joining and relieve them on the same day to re-join to the deputationist Organization (SOG, SIW as the case may be) to complete their residual period of deputation. They will join back SOG, SIW without availing joining time.
4. They will be relieved by SOG/ SIW on completion of their tenure of deputation (if not extended).
5. A broad sheet showing name, district of the deployment, deputed Organization and period of deputation and other details of each such Sepoy is enclosed herewith.

This issues with approval of DGP.


