The finding of the Special Central Selection Board held on 13.12.2013 in respect of Ex-Havildar Major, Santanu Kumar Sahoo of OSAP 4th SS Battalion, Malkangiri (Spl. CSB Sl. No.38) for promotion to the rank of Deputy Subedar was kept in individual sealed cover due to pendency of Rourkela Plant Site PS Case No.8 dtd 07.01.2013 U/s 3 OPG Act (GR No.54/2013 against him. In the said case the Hon'ble Court of JMFC, Rourkela found him not guilty of the charges vide his order dtd 26.03.2014. As per orders of the DGP on the basis of the G.A. Department Office Memorandum No.3928/Gen dtd 18.02.1994, the sealed cover containing findings of the Spl. CSB 2013 regarding his promotion has been opened.

It is found that he was selected by the Spl. CSB 2013 held on 13.12.2013 for promotion to the rank of Deputy Subedar, but, he was allowed promotion to the rank of Deputy Subedar vide S.P. Hdqrs. Office Order No.592/Pers-II dtd 20.05.2016 as per the results of the CSB 2016 held on 19.05.2016.

In view of the above, Deputy Subedar Santanu Kumar Sahoo of OSAP 4th SS Battalion, Malkangiri is allowed retrospective promotion in the rank of Deputy Subedar w.e.f. the date his immediate junior Ex-Havildar Major Nimai Charan Sahu (Now Deputy Subedar) (Special CSB No.39) was promoted to the rank of Deputy Subedar as per the results of the Spl. CSB held on 13.12.2013. Accordingly, the inter-se-seniority of Sri Santanu Kumar Sahoo is fixed in the rank of Dy. Subedar above Sri Nimai Charan Sahu who was allowed promotion to the rank of Dy. Subedar vide Office Order No.1248/Tech. dtd 17.12.2013.

His pay in the rank of Deputy Subedar shall be fixed notionally from the date his immediate junior Sri Nimai Charan Sahu was promoted to the rank of Deputy Subedar.

This has been approved by the DG & IG of Police, Odisha, Cuttack.
