Office Order No. 303 /Pers-II Date. 07.03.2019.

The finding of the Central Selection Board held on 20.06.2013 in respect of Ex-Havildar Major Dhaneswar Roul of OSAP 1<sup>st</sup> Bn., Dhenkanal (CSB Sl.No.27) for promotion to the rank of Deputy Subedar was kept in individual sealed cover due to pendency of 2<sup>nd</sup> I.R. Bn., Rayagada Proceeding No.6/12 in which he was awarded a Major punishment of "forfeiture of increment for a period of six months with cumulative effect carrying the value of one Black Mark" vide 2<sup>nd</sup> I.R. Bn., Rayagada B.O. No.873 dtd.10.10.2013, which was set aside by the D.I.G. of Police, SAP, Odisha, Cuttack on his appeal, published vide 2<sup>nd</sup> I.R. Bn., Rayagada B.O. No.502 dtd.1.5.2014. As per orders of the DGP on the basis of the G.A. Department Office Memorandum No.3928/Gen. dtd.18.02.1994, the sealed cover containing findings of the CSB-2013 regarding his promotion has been opened.

It is found that he was selected by the above CSB-2013 for promotion to the rank of Deputy Subedar, but he was allowed promotion to the rank of Deputy Subedar vide S.P. Hdqrs. Office Order No.200/Tech. dtd.11.03.2015 as per the results of the CSB-2015 held on 3.3.2015.

In view of the above, Deputy Subedar Dhaneswar Roul of OSAP 1<sup>st</sup> Bn., Dhenkanal is allowed retrospective promotion in the rank of Deputy Subedar w.e.f. the date his immediate junior Ex-Havildar Major Kishore Chandra Ray (Now Deputy Subedar) (C.S.B. No.28) was promoted to the rank of Deputy Subedar as per the results of the CSB held on 20.06.2013. Accordingly, the inter-se-seniority of Sri Dhaneswar Roul is fixed in the rank of Dy. Subedar above Sri Kishore Chandra Ray who was allowed promotion to the rank of Dy. Subedar vide Office Order No.667/Tech. dtd.21.06.2013.

His pay in the rank of Deputy Subedar shall be fixed notionally from the date his immediate junior Sri Kishore Chandra Ray as promoted to the rank of Deputy Subedar.

This has been approved by the D.G. & I.G. of Police, Odisha, Cuttack.
