The case of C/237 Gobinda Chandra Khatua (SC) of Bhadrak district (CSB SI. No.05) was placed before the Special Central Selection Board for the year 2022 convened on 22.09.2022. The CSB after scrutinizing his service record, decided to keep their recommendation in a sealed cover in pursuance of G.A. Department O.M. No. 3928/Gen. dtd 18.02.1994, as Cuttack Vigilance PS case No. 20/2002 was pending against him during the time of Special CSB.

Thereafter. C/237 Gobinda Chandra Khatua has submitted a representation for consideration of his promotion to Officiate as ASI of Police, as he was acquitted in the Cuttack Vigilance PS case No.20/2002 by the Hon'ble Court of Special Judge (Vigilance), Balasore vide order dtd 20.01.2023.

The matter was examined and placed before the DGP. As per orders of DGP, the sealed cover containing findings of the Special CSB for the year 2022 held on 22.09.2022 in respect of C/ 237 Gobinda Chandra Khatua of Bhadrak district was opened on 28.06.2024 and found that he has been selected by the Special CSB for the year 2022 held on 22.09.2022 for promotion to officiate as ASI of Police.

Having been selected by the Special CSB held on 22.09.2022, C/237 Gobinda Chandra Khatua of Bhadrak district is allowed to undergo ASI course of training in the next batch, in accordance with Govt. of Odisha, Home Department Notification No.33854/D&A dtd 15.10.2020.
