OFFICE ORDER No. **569** /Pers-I, Dated **12** 07.2024

The case of Constable/457 Ranjit Kumar Lima of Gajapati district (CSB SI. No.108) was placed before the Central Selection Board for the year 2023 convened on 05-06.12.2023. The CSB after scrutinizing her service record, decided to keep their recommendation in a sealed cover in pursuance of G.A. Department O.M.No.3928/Gen. dtd 18.02.1994, as Gajapati district Proceeding No. 05/2019 was pending against him.


Thereafter. Constable/457 Ranjit Kumar Lima has submitted a representation for consideration of his promotion to Officiate as ASI of Police, as the allegation could not be established against him in Berhampur Vigilance PS case No.56 dtd 30.12.2018 as stated by the Supdt. of Police, Vigilance, Berhampur Division vide letter No.268/VP-BPR dtd 11.03.2024. Furthermore, he was exonerated in Gajapati district Proceeding No. 05/2019 by the Disciplinary Authority vide Gajapati District D.O.No.474 dtd 17.05.2024.

The matter was examined and placed before the DGP. As per orders of DGP, the sealed cover containing findings of the CSB for the year 2023 convened on 05-06.12.2023 in respect of Constable/457 Ranjit Kumar Lima and found that he has been selected by the CSB for promotion to officiate as ASI of Police.

Having been selected by the CSB for the year 2023 held on 05-06.12.2023, Constable C/457 Ranjit Kumar Lima of Gajapati District is allowed to undergo ASI course of training in the next batch, in accordance with Govt. of Odisha, Home Department Notification No.33854/D&A dtd 15.10.2020.


