OFFICE ORDER No. 570 /Pers-I, Dated 12 07.2024

The case of C/457 Ranjit Kumar Samal of Malkangiri district (CSB Sl. No.816) was placed before the CSB for the year 2022 held on 21-23.09.2022. The CSB after scrutinizing his service record, decided to keep their recommendation in a sealed cover in pursuance of G.A. Department O.M. No. 3928/Gen. dtd 18.02.1994, as Malkangiri district Proceeding No. 13/2022 was pending against him.

Further, his case was placed before the CSB for the year 2023 convened on 05-06.12.2023 (CSB Sl. No.95) for consideration of his promotion to Officiate as ASI of Police. The CSB has adopted the same sealed cover procedure as Malkangiri district Proceeding No.13/2022 was pending against him.


Thereafter, he has submitted a representation for consideration of his promotion to Officiate as ASI of Police, as he has been awarded with a minor punishment "Censure in SB" in Malkangiri district Proceeding No. 13/2022 by the Disciplinary Authority vide D.O. No. 299 dtd 12.02.2024.

The matter was examined and placed before the DGP. As per orders of DGP, the sealed cover containing findings of the CSB for the year 2022 held on 21-23.09.2022 and 2023 held on 05-06.12.2023 in respect of C/ 457 Ranjit Kumar Samal of Malkangiri district was opened on 26.06.2024 and found that he has been selected by the CSB for the year 2022 held on 21-23.09.2023 for promotion to officiate as ASI of Police.

Having been selected by the CSB for the year-2022 held on 21-23.09.2022, C/457 Ranjit Kumar Samal of Malkangiri district is allowed to undergo ASI course of training in the next batch, in accordance with Govt. of Odisha, Home Department Notification No.33854/D&A dtd 15.10.2020.
