OFFICE ORDER No. **571** /Pers-I, Dated **12-07** 2024

The case of C/1023 Bijayalaxmi Nanda of Keonjhar district (CSB SI. No. 275) was placed before the CSB for the year 2022 held on 21-23.09.2022 for determining her promotion to Officiate as ASI of Police. The CSB after scrutinizing her service record, decided to keep their recommendation in a sealed cover in pursuance of G.A. Department O.M. No.3928/Gen. dtd 18.02.1994 and subsequent amendment made to it, as Kendrapara district Proceeding No. 02/2020 and Kendrapara Town PS case No.125/2019 were pending against her.

Again, her case was placed before Central Selection Board for the year 2023 (CSB SI. No.57) convened on 05-06.12.2023 for determining her promotion to the rank of OASI of Police. The CSB after scrutinizing her service record adopted the same sealed cover procedure as Kendrapara district Proceeding No. 02/2020 and Kendrapara Town PS case No.125/2019 were pending against her.


After being acquitted in Kendrapara Town PS case No.125/2019 by the Hon'ble SDJM, Kendrapara vide order dtd 11.11.2022 and found not guilty in Kendrapara district Proceeding No.02/2020 by the Disciplinary Authority vide order dtd 05.04.2024, C/1023 Bijayalaxmi Nanda submitted a representation for consideration of her promotion to officiate as ASI of Police.

The matter was examined and placed before the DGP. As per orders of DGP, the sealed cover containing findings of the CSB for the year 2022 held on 21-23.09.2022 and 2023 held on 05-06.12.2023 in respect of C/ 1023 Bljayalaxmi Nanda of Keonjhar district was opened on 28.06.2024 and found that she has been selected by the CSB for the year 2022 held on 21-23.09.2022 and 2023 held on 05-06.12.2023 respectively.

Having been selected by the CSB for the year 2022 held on 21-23.09.2022, C/1023 Bljayalaxmi Nanda of Keonjhar district is allowed to undergo ASI course of training in the next batch, in accordance with Govt. of Odisha, Home Department Notification No.33854/D&A dtd 15.10.2020.


