OFFICE ORDER No. 572 /Pers-I, Dated 12 07.2024

The case of Constable Jitendra Kumar Sangramsingh of Rourkela Police district (now deputed to SIW, Bhubaneswar) (CSB Sl. No.212) was placed before the Central Selection Board for the year 2022 convened on 21-23.09.2022. The CSB after scrutinizing his service record, decided to keep their recommendation in a sealed cover in pursuance of G.A. Department O.M.No.3928/Gen. dtd 18.02.1994, as Angul district Proceeding Nos. 14/2021 & 15/2021 were pending against him. Again, his case was placed before the Central Selection Board for the year 2023 (CSB Sl. No.41) convened on 05/06.12.2023 for his promotion to Officiate as ASI of Police. The Central Selection Board after scrutinizing his service record adopted the same sealed cover procedure as Angul district Proceeding Nos. 14/2021 & 15/2021 were pending against him.


Thereafter. Constable Jitendra Kumar Sangramsingh has submitted a representation for consideration of his promotion to Officiate as ASI of Police, as he has been awarded with minor punishments "Warned in SB" in Angul district Proceeding No. 14/2021 and "warning to be recorded in the Service Book" in Angul district proceeding No.15/2021 vide Angul D.O. No. 843 dtd 03.05.2024 and D.O. No. 731 dtd 19.04.2024 respectively.

The matter was examined and placed before the DGP. As per orders of DGP, the sealed cover containing findings of the Special CSB for the year 2022 held on 21-23.09.2022 in respect of Constable Jitendra Kumar Sangramsingh was opened on 29.06.2024 and found that he has been selected by the Special CSB for the year 2022 held on 21-23.09.2022 for promotion to officiate as ASI of Police.

Having been selected by the CSB for the year 2022 held on 21-23.09.2022, Constable Jitendra Kumar Sangramsingh of Rourkela Police District (now deputed to SIW) is allowed to undergo ASI course of training in the next batch, in accordance with Govt. of Odisha, Home Department Notification No.33854/D&A dtd. 15.10.2020.


