OFFICE ORDER No. **573** /Pers-I, Dated **12** 07.2024

The case of CI Havildar/631 Jitendra Kumar Patel of Sundargarh district (CSB Sl. No.19) was placed before the CSB for the year 2022 held on 21-23.09.2022. The CSB after scrutinizing his service record have selected CI Havildar/631 Jitendra Kumar Patel to undergo ASI Course of Training.

While the matter stood thus, the Supdt. of Police, Sundargarh vide his letter No. 8303/RO, dtd. 14.10.2022 has intimated that Sundargarh district Proceeding No. 09/2022 has been initiated against him in the meantime. Hence, he was not allowed to undergo ASI Course of training. His case was treated as "kept in a sealed cover" in pursuance of G.A. Department O.M.No.3928/Gen. dtd 18.02.1994.


Thereafter, he has submitted a representation duly forwarded by the Supdt. of Police, Sundargarh vide letter No. 4321/E, dtd. 21.06.2024 for consideration of his promotion to OASI of Police, as in the meantime the said proceeding has been disposed of by awarding a minor punishment "Censured in S.B." by the Disciplinary Authority vide D.O. No. 1000, dtd 13.06.2024.

Since, the case of CI Havildar/631 Jitendra Kumar Patel of Sundargarh district was treated as kept in a sealed cover, in view of disposal of Sundargarh district Proceeding No. 09/2022 by awarding a minor punishment, the result of CSB-2022 is hereby published.

Having been selected by the CSB for the year 2022 held on 21-23.09.2022, CI Havildar/631 Jitendra Kumar Patel of Sundargarh district is allowed to undergo ASI course of training in the next batch, in accordance with Govt. of Odisha, Home Department Notification No.33854/D&A dtd 15.10.2020.


