OFFICE ORDER No. 749 /Pers. I Date: 04.05.2023

The case of Ex.S.I. Sabita Patra now Inspector of Police in Dhenkanal district was placed before the Central Selection Board for the year 2019 (CSB Sl. No.209) for consideration of her promotion to the rank of Inspector of Police. She was not selected by the CSBs due to her bad service record as 07 minor punishments were at her discredit during the preceding five years of the CSB-2019.

On consideration of her appeal petition, against above minor punishments, the DIG of Police, NCR, Talcher was pleased to set aside 3 minors punishments out of 07 which were published vide Angul D.O.Nos.1541 & 1542 dtd 13.08.2020 and Dhenkanal D.O.No.1289 & 1290 dtd 05.09.2020 respectively.

Thereafter, she has submitted a representation to DGP for consideration of her promotion to the rank of Inspector of Police retrospectively with effect from the date her junior got promotion vide State Police Hdqrs. Office Order No.626/Pers.I dtd 26.06.2019.

On consideration of her representation, DGP has been pleased to pass order to hold a Spl. CSB for consideration of her retrospective promotion to the rank of Inspector of Police against CSB-2019.

Having been selected by the Spl. C.S.B. held on 29.04.2023, Inspr. Sabita Patra is allowed promotion to the rank of Inspr. of Police retrospectively from the date her immediate junior Ex.S.I.Ranjo Hasini Kullu (ST) (CSB Sl. No.210 of 2019) who was allowed promotion to the rank of Inspr. of Police vide State Police Hdqrs. Office Order No.626/Pers.I dtd 26.6.2019. Her seniority is fixed above Ranjo Hasini Kullu, Inspector of Police.

Her pay will be fixed notionally in the time scale of pay of Inspr. of Police from the date her immediate junior was allowed promotion to the rank of Inspector of Police. She is not entitled to any financial benefits for the period she has not actually worked in the higher grade/post.
