OFFICE ORDER No. **750** /Pers. I Date: **04-05.2023**

The case of Ex. S.I. Sarita Kumari Mohapatra (CSB SI. No.223 of CSB-2010) now Inspector of Police, CAW&CW,CID,CB, Odisha, Bhubansewar was placed before the Central Selection Board for the year 2010 convened on 25.05.2011 for consideration of her promotion to the rank of Inspector of Police. The Central Selection Board after scrutinizing her service record considered to keep the findings in respect of her in a sealed cover in pursuance of Govt. of Odisha, G.A.Deptt. Office Memorandum No.3928/Gen. dtd 18.02.1994, as Berhampur Vigilance PS case No.27/2008 and Berhampur district Proceeding No. 01/2011 were pending against her. Her case was again placed before the CSB for the year 2011, 2012, 2013, 2014,2015, 2016, 2017 & 2018 respectively for promotion to the rank of Inspector of Police, the CSB has adopted the same procedure as Berhampur Vigilance PS case No.27/2008 and Berhampur district Proceeding No. 01/2011 was pending against her.

After acquitted in Berhampur Vigilance PS case No.27/2008 by the Court of Hon'ble Special Judge, Vigilance, Bhubaneswar on 20.11.2018 and also after disposal of Berhampur district Proceeding No. 01/2011 initiated against her by exonerating her from all the charges. Ex.S.I.Sarita Kumari Mohanty claimed for consideration of her retrospective promotion to the rank of Inspector of Police from the year 2019.

Thereafter, the matter was placed before the DGP to accord his permission to open the sealed cover in respect of Ex.S.I. Sarita Kumari Mohapatra. Upon approval of the order of the DGP, the sealed cover containing the recommendation of CSBs for the year 2010 to 2014 pertaining to her retrospective promotion to the rank of Inspector of Police was opened on 19.02.2019 and found that she has not been selected by the CSBs from 2010 to 2014 and selected from 2015 to 2018. Accordingly, she was allowed promotion to the rank of Inspector of Police retrospectively w.e.f. 09.12.2015 vide S.P.Hdqrs. Office Order No.753/Pers.I dtd 16.08.2019. Her seniority was fixed below the Inspector Nirnajan Behera of Spl. Branch, Odisha, Bhubaneswar.

Due to her adverse CCR for the period from 01.04.2008 to 31.03.2009, she was not selected by the CSB 2010 to 2014 for promotion to the rank of Inspector of Police. In the meantime, on consideration of her representation, the DGP has been pleased to expunge the adverse remarks recorded in the CCR for the period from 01.04.2008 to 31.03.2009 and classified it as "No remarks" vide order dtd 22.09.2022.

In order to consider her retrospective promotion to the rank of Inspector of Police against CSB-2010, her nomination roll and other records were called for from Addl. D.G. of Police, CAW & CW, CID,CB, Bhubaneswar and all the records receive from CAW&CW are placed before the review CSB.

After scrutinizing the nomination rolls, CCRs and other records of Inspector Sarita Kumari Mohapara, the Review CSB found her suitable for promotion to the rank of Inspector of Police retrospectively from the date her juniors have been promoted to the rank of Inspector of Police as per recommendation of the CSB for the year 2010 held on 25.05.2011.

Having been selected by the Review C.S.B. held on 29.04.2023, Inspector Sarita Kumari Mohapatra is allowed promotion to the rank of Inspector of Police retrospectively from the date her immediate junior Inspector Bhagyalaxmi Puhan (CSB SI. No.224 of 2010) of Angul district who was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No.1398 dtd 30.06.2011. Her seniority is fixed above Bhagyalaxmi Puhan now Deputy Supdt. of Police.

Her pay will be fixed notionally in the time scale of pay of Inspector of Police from the date her immediate junior was allowed promotion to the rank of Inspector of Police. She is not entitled to any financial benefits for the period she has not actually worked in the higher grade/post.

This issues with the approval of DGP.


