

## ODISHA POLICE STATE HEADQUARTERS CUTTACK.

OFFICE ORDER No. 753

The case of S.I. Jugal Kishore Sa (CSB Sl.No.143 of 2021) of Sambalpur district was placed before the CSB-2021 held at State Police Hdqrs., Cuttack on 8/9.11.2021 for consideration of his promotion to the rank of Inspector of Police but the CSB after duly scrutinizing his service record did not considered him for promotion to the rank of Inspector of Police, as one major punishment i.e. Two Black marks was pending against him.

On consideration of the appeal petition of SI Jugal Kishore Sa of Sambalpur district , the IG of Police, NR, Sambapur has reduced the quantum of major punishment (Two Black Mark) to minor punishment "Censure in SB" vide D.O.No.2767 dtd 14.09.2022.

After scrutinizing the nomination Rolls , CCRs and other records of S.I. Jugal Kishore Sa, the Review Selection Board found him "suitable" for promotion to the rank of Inspector of Police retrospectively with effect from the date his immediate junior Ex. S.I. Alok Kumar Behera (CSB SI. No.144 of 2021) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 1079/Pers.I dtd 11.11.2021. Accordingly his seniority in the rank of Inspector of Police is fixed above Inspector Ex.S.I. Alok Kumar Behera.

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade post.

On such promotion, he is posted to **Koraput district** pending approval by Police Establishment Board.

This issues with the approval of DGP.
