OFFICE ORDER No. 7 5 5 /Pers-I, Dated 04.05.2023

The case of S.I. Arun Kumar Singh (SC) (CSB Sl.No.67 of 2021) of Boudh district was placed before the CSB-2021 held at State Police Hdqrs. , Cuttack on 27.05.2022 for consideration of his promotion to the rank of Inspector of Police but the CSB after duly scrutinizing his service record did not recommend him for promotion to the rank of Inspector of Police due to pendency of 10 minor punishments.

In the meantime, on consideration of appeal petition, the DIG of Police, NCR, Talcher has been pleased to set aside the 06 minor punishments and the same has been published vide Deogarh D.O.No.1002 dtd 15.11.2022 and D.O.No.919 dtd 11.10.2022 respectively. There were 04 minor punishments remain against her. DGP has been pleased to set aside the 2 minor punishments of Censure on 10.11.2022 which was awarded which was awarded to him vide Deogarh D.O.No.286 dtd 17.4.2017 and D.O.No.1048 dtd 14.11.2017 respectively.


After scrutinizing the nomination Rolls , CCRs and other records of S.I. Arun Kumar Singh, the Review Selection Board found him "suitable" for promotion to the rank of Inspector of Police retrospectively with effect from the date his immediate junior Ex. S.I. Mamata Hemrom (ST) (CSB Sl. No.69 of 2021) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 561/Pers.I dtd 27.05.2022. Accordingly her seniority in the rank of Inspector of Police is fixed above Ex.S.I. Mamata Hemrom.

His pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of his immediate junior was allowed promotion to the rank of Inspector of Police. He is not entitled to any financial benefits for the period he has not actually worked in the higher grade post.

On such promotion, he is posted to **Ganjam district** pending approval by Police Establishment Board.

This issues with the approval of DGP.


