OFFICE ORDER No. 7 5 6 /Pers-I, Dated 04. 05.2023

The case of S.I. Sanghamitra Mohanty (CSB Sl.No.150 of 2021) of Spl. Branch, Bhubaneswar was placed before the CSB-2021 held at State Police Hdqrs. , Cuttack on 27.05.2022 for consideration of her promotion to the rank of Inspector of Police but the CSB after duly scrutinizing her service record, 08 minor punishments were pending against her which is within the preceding five years of the CSB-2021 and not recommended her promotion to the rank of Inspector of Police.

In the meantime, on consideration of appeal petition of S.I. Sanghamitra Mohanty, the DIG of Police, NCR, Talcher has been pleased to set aside the 03 minor punishments out of 08 vide Deogarh D.O.No.959 dtd 28.10.2022.


After scrutinizing the nomination Rolls , CCRs and other records of S.I. Sanghamitra Mohanty, the Review Central Selection Board found her "suitable" for promotion to the rank of Inspector of Police retrospectively with effect from the date her immediate junior Ex. S.I. Anna Minz (CSB Sl. No.151 of 2021) was allowed promotion to the rank of Inspector of Police vide State Police Hdqrs. Office Order No. 561/Pers.I dtd 06.06.2022. Accordingly her seniority in the rank of Inspector of Police is fixed above Inspector Ex.S.I. Anna Minz.

Her pay will be fixed notionally in the time scale of pay of Inspector of Police from the date of her immediate junior was allowed promotion to the rank of Inspector of Police. She is not entitled to any financial benefits for the period she has not actually worked in the higher grade post.

On such promotion, she is posted to **Bhadrak district** pending approval by Police Establishment Board.

This issues with the approval of DGP.
