OFFICE ORDER NO. 758 /PERS.I DTD. 04.05.2023

The case of ASI Nabaghana Sahoo of UPD, Bhubaneswar (CSB Sl. No.124) for consideration of his promotion to the rank of S.I. of Police was placed before the CSB for the year 2023 held on 13.04.2023. The Central Selection Board after scrutinizing his service record considered to keep their recommendation in respect of him in a sealed cover in pursuance of G.A. Deptt. Office Memorandum No.3928/Gen. dtd 18.02.1994, as Sambalpur Vigilance PS case No.49/2015 and Deogarh district Proceeding No.02/2016 are pending against him basing on the report received from S.P. (Co-ordination), Vigilance, Directorate, Odisha, Cuttack vide letter No.28670/VCO(B) dtd 20.12.2022.

ASI Nabaghana Sahoo has submitted a representation for consideration of his promotion to the rank of S.I. of Police as no Sambalpur Vigilance PS case No. 49/2015 and Deogarh district Proceeding No. 02/2016 are pending against him. On scrutiny of Vigilance report submitted by S.P. (Co-ordination), Vigilance Directorate, Odisha, Cuttack vide letter No.28670/VCO(B) dtd 20.12.2022, it is found that Sambalpur Vigilance PS case No.49/2015 is pending against ASI Nabaghana Sahoo of UPD, Bhubaneswar.


Subsequently, the Supdt. of Police (Co.ordination) , Vigilance Directorate vide letter dtd 02.05.2023 has informed that no Vigilance case/inquiry is pending against Sri Nabaghana Sahoo son of Baidhar Sahoo, ASI of Police, UPD, Bhubaneswar.

After getting clarification from Vigilance Directorate, the case of ASI Nabaghana Sahoo was placed before DGP. As per orders of the DGP the sealed cover containing the findings of the CSB for the year 2023 in respect of ASI Nabaghana Sahoo of UPD, Bhubaneswar was opened on 04.05.2023 and found that he has been selected by the CSB for the year 2023 held on 13.04.2023.

Hence, ASI Nabaghana Sahoo of UPD, Bhubaneswar is allowed to the rank of Sub-inspector of Police with effect from the date of his joining at training centre for undergoing DCSI course of training for a period of six months as per Home Deptt. Notification No.4888/D&A dtd 5.2.2021. His seniority in the rank of Sub-Inspector of Police on promotion fixed above S.I. Shyamaghana Swain (CSB Sl. No. 125) immediate junior to him who was allowed promotion to the rank of Sub- Inspector of Police vide State Police Hdqrs. Office Order No.524/Pers.I dtd 24.04.2023 being selected by the CSB -2023 held on 13.04.2023. He will report at PTC, Angul on 06.05.2023 for undergoing DCSI course of training .
