OFFICE ORDER NO. 759 /PERS.I DTD. 04.05.2023

The case of ASI Ashok Kumar Mohanty (B) Son of late Abakash Mohanty of Jagatsinghpur district (CSB Sl. No.174) for consideration of his promotion to the rank of S.I. of Police was placed before the CSB for the year 2023 held on 13.04.2023. The Central Selection Board after scrutinizing his service record considered to keep their recommendation in respect of him in a sealed cover in pursuance of G.A. Deptt. Office Memorandum No.3928/Gen. dtd 18.02.1994 due to pendency of Bhubaneswar Vigilance PS case No.23/2013 against him.

ASI Ashok Kumar Mohanty son of late Abakash Mohanty appeared in grievance on 25.04.2023 and prayed that during his service period no vigilance / criminal case/ Departmental proceeding or major punishment is pending against him. This matter was examined Board Section and in this connection Director Vigilance was requested to verify and intimate if Bhubaneswar Vigilance PS case No.23/2013 was pending against Ashok Kumar Mohanty (B) Son of late Abakash Mohanty. But, S.P., Vigilance(Co-ordination) has intimated vide letter No.7687/VCO(B) dtd 25.04.2023 that no vigilance case was pending against Ashok Kumar Mohanty (B) of Jagatsinghpur district.

After getting clarification from Vigilance Directorate, the case of ASI Ashok Kumar Mohanty (B) was placed before DGP. As per orders of the DGP the sealed cover containing the findings of the CSB for the year 2023 in respect of ASI Ashok Kumar Mohanty(B) of Jagatsinghpur district was opened on 27.04.2023 and found that he has been selected by the CSB for the year 2023 held on 13.04.2023.

Hence, ASI Ashok Kumar Mohanty son of late Abakash Mohanty of Jagatsinghpur district is allowed promotion to the rank of Sub-inspector of Police with effect from the date of his joining at training centre for undergoing DCSI course of training for a period of six months as per Home Deptt. Notification No.4888/D&A dtd 5.2.2021. His seniority in the rank of Sub-Inspector of Police on promotion fixed above S.I. Rama Chandra Hati (CSB Sl. No. 175) immediate junior to him who was allowed promotion to the rank of Sub- Inspector of Police vide State Police Hdqrs. Office Order No.524/Pers.I dtd 24.04.2023 being selected by the CSB -2023 held on 13.04.2023. He will report at PTC, Angul on 06.05.2023 for undergoing DCSI course of training .
