OFFICE ORDER NO. **760** /PERS.I DTD. **04.05.2023**

The case of ASI Arun Kumar Mallick of UPD, Bhubaneswar (CSB Sl. No.225) for consideration of his promotion to the rank of S.I. of Police was placed before the CSB for the year 2023 held on 13.04.2023. The Central Selection Board after scrutinizing his service record considered to keep their recommendation in respect of him in a sealed cover in pursuance of G.A. Deptt. Office Memorandum No.3928/Gen. dtd 18.02.1994 due to pendency of Badmal PS case No.158 dtd 24.12.2013 U/s 341/ 294/ 323/354/506 IPC (Jhasuguda SR No.156/2013) against him basing on the report from S.P., CID,CB, Odisha, Cuttack.


ASI Arun Kumar Mallick represented for consideration of his promotion to the rank of S.I. of Police as no Badmal PS case No.158 dtd 24.12.2013 U/s 341/294/323/354/506 IPC (Jhasuguda SR No.156/2013) is pending against him. On scrutiny of Crime Branch report submitted by S.P., CID,CB, Odisha, Cuttack vide letter No.19671/CID-SR-P dtd 09.12.2022, it is found that Badmal PS case No.158 dtd 24.12.2013 U/s 341/294/323/354/506 IPC (Jhasuguda SR No.156/2013) was registered against ASI Arun Kumar Mallick while posted at Badmal PS under Jhasuguda district. As per the judgement on dtd 05.09.2018 by the Hon'ble JMFC, Jhasuguda, Ex. ASI Arun Kumar Mallick of Jhasuguda district (now in UPD, Bhubaneswar) has been found not guilty on charges U/s 341/294/323/354/506 IPC and acquitted under the provision U/s 248(1) of Cr.P.C.

The matter was examined and placed before the DGP. As per orders of the DGP, the sealed cover containing the recommendation of the CSB in respect of ASI Arun Kumar Mallick of UPD, Bhubaneswar was opened on 02.05.2023 and found that he has been selected by the CSB for the year 2023.

Hence, ASI Arun Kumar Mallick of UPD, Bhubaneswar is allowed promotion to the rank of Sub-inspector of Police with effect from the date of his joining at training centre for undergoing DCSI course of training for a period of six months as per Home Deptt. Notification No.4888/D&A dtd 5.2.2021. His seniority in the rank of Sub-Inspector of Police on promotion fixed above S.I. Manas Ranjan Mishra of Police Commissionerate (CSB Sl. No. 226) immediate junior to him who was allowed promotion to the rank of Sub-Inspector of Police vide State Police Hdqrs. Office Order No.524/Pers.I dtd 24.04.2023 being selected by the CSB -2023 held on 13.04.2023. He will report at PTC, Angul on 06.05.2023 for undergoing DCSI course of training .


