The case of ASI K. Laxminarayan Dora of Malkangiri district (CSB Sl. No.162) for consideration of his promotion to the rank of S.I. of Police was placed before the CSB for the year 2023 held on 13.04.2023. But he was not selected by the CSB due to having adverse CCR remarks recorded in his CCR for the year 2020-21 which was during preceding five years of the CSB for the year 2023.

ASI K.Laxminarayan Dora has appeared grievance before DGP for consideration of his promotion to the rank of S.I. of Police. Wherein ASI Dora has asserted that the then S.P., Malkangiri who was his accepting authority in his CCR during the period from 01.04.2020 to 18.02.2021 has made comments on Average and lack of sincerity which was communicated to him vide Memo No.57/Con. dtd 18.01.2022.

After careful consideration of the case of ASI K.Laxminarayan Dora of Malkangiri district, DGP vide order dtd 01.05.2023 has passed the following order;

In the light of the instruction of the Government on the subject, the ACR be read as "Average" with no adverse connotation".

Hence, ASI K.Laxminarayan Dora of Malkangiri district is allowed promotion to the rank of Sub-inspector of Police with effect from the date of his joining at training centre for undergoing DCSI course of training for a period of six months as per Home Deptt. Notification No.4888/D&A dtd 5.2.2021. His seniority in the rank of Sub-Inspector of Police on promotion fixed above S.I. Biswanath Kar of Balasore district (CSB Sl. No. 163) immediate junior to him who was allowed promotion to the rank of Sub- Inspector of Police vide State Police Hdqrs. Office Order No.524/Pers.I dtd 24.04.2023 being selected by the CSB -2023 held on 13.04.2023. He will report at PTC, Angul on 06.05.2023 for undergoing DCSI course of training .
