
The case of ASI Sambhuti Panda of Angul district (CSB Sl. No.211) for consideration of his promotion to the rank of S.I. of Police was placed before the CSB for the year 2023 held on 13.04.2023. But he was not selected by the CSB due to having adverse CCR remarks recorded in his CCR for the year 2019-20 which was during preceding five years of the CSB for the year 2023. Against the adverse remarks, ASI Panda has preferred an appeal before DIG of Police, NCR, Talcher for expunction of his adverse remarks recorded in his CCR for the year 2019-20. On consideration of his representation of ASI Sambhuti Panda of Angul district, DIG of Police, NCR, Talcher has expunged the adverse remarks recorded in his CCR for the year 2019-20 vide order dtd 17.10.2022.

Thereafter, ASI Sambhuti Panda has submitted a representation for consideration of his promotion to the rank of S.I. of Police. On consideration of his representation, DGP has been pleased to pass orders to hold a Spl. CSB to consider the case of ASI Sambhuti Panda of Angul district for promotion to the rank of S.I. of Police. After scrutinizing the nomination rolls, CCRs and other related documents in respect of ASI Sambhuti Panda, the Review Central Selection Board found him suitable for promotion to the rank of S.I. of Police.

Hence, ASI Sambhuti Panda of Angul district is allowed promotion to the rank of Sub-inspector of Police with effect from the date of his joining at training centre for undergoing DCSI course of training for a period of six months as per Home Deptt. Notification No.4888/D&A dtd 5.2.2021. His seniority in the rank of Sub-Inspector of Police on promotion fixed above S.I. Basant Kumar Routray of SRP, Rourkela (CSB Sl. No. 212) immediate junior to him who was allowed promotion to the rank of Sub-Inspector of Police vide State Police Hdqrs. Office Order No.524/Pers.I dtd 24.04.2023 being selected by the CSB -2023 held on 13.04.2023. He will report at PTC, Angul on 06.05.2023 for undergoing DCSI course of training.


