The Central Selection Board for the year-2023 was held on 22.06.2023 for promotion of SI (Communication) to the rank of Inspector (Communication) in Signals Establishment. The case of SI (Communication) Jyotimohan Mohanty of Signals Establishment (CSB SI. No.2) was placed before the CSB on 22.06.2023 for consideration his promotion to the rank of Inspector (Communication). The CSB after scrutinizing the service record of Jyotimohan Mohanty decided to keep his recommendation in a sealed cover in pursuance of Govt. of Odisha G.A. Department Office memorandum No.3928/Gen dtd.18.02.1994 and subsequent amendment to the above provision due to pendency of Signals Establishment Proceeding No. 03/2023 drawn up against him.

The said Proceeding No. 03/2023 has been disposed of and Shri Jyotimohan Mohanty, SI (Communication) is awarded with a minor punishment of "Censure in SB". Shri Mohanty has submitted a representation dtd.11.03.2024 for consideration of his retrospective promotion to the rank of Inspector (Communication).

As per orders of the DGP the sealed cover containing findings of the CSB-2023 held on 22.06.2023 in respect of SI (Communication) Jyotimohan Mohanty of Signals Establishment was opened on 22.08.2024 and found that he has been selected by the CSB for the year-2023 held on 22.06.2023 for promotion to the rank of Inspector of Police (Communication).


Having been selected by the CSB, 2023 held on 22.06.2023, SI (Communication) Jyotimohan Mohanty of Signals Establishment is allowed retrospective promotion to the rank of Inspector of Police (Communication) w.e.f. the date his immediate junior SI (Communication) Adeita Ch. Pradhan (now Inspector of Police (Communication) (CSB SI. No.- 3) was promoted to the rank of Inspector of Police (Communication) as per the results of the CSB held on 22.06.2023. His promotion is subject to the final outcome of W.A No. 193/2023 arising out of W.P (C) No.27381/2019 filed by Amiya Kumar Das and others and W.P(C) No. 12609/2023 filed by Durga Charan Swain- vrs.-State of Odisha and others..

The inter-se-seniority of SI (Communication) Jyotimohan Mohanty is fixed in the rank of Inspector of Police (Communication) above Adeita Ch. Pradhan (CSB SI. No.-3) who was allowed promotion to the rank of Inspector of Police (Communication) vide S.P. Hdqrs. Office Order No.947/Pers.-II dtd.27.06.2023.

His pay in the rank of Inspector of Police (Communication) shall be fixed notionally from the date his immediate junior Adeita Ch. Pradhan allowed promotion to the rank of Inspector of Police (Communication). His promotional posting will be decided by the Range Police Establishment Board of Signals Establishment.


