In pursuance to Order dtd 21.12.2022 passed by Hon'ble High Court of Orissa in W.P. © No.10268 of 2021 and Odisha Staff Selection Commission Notification No. 1907/OSSC dtd 16.05.2023, Miss Dipali Majhi (SEBC) (Female) is hereby appointed temporarily as Sub-Inspector of Police - 2016 on regular basis with basic pay of Rs.35400/- PM (Cell-1 of Level-9) in ORSP Rule 2017 with usual D.A. and other Allowances as admissible from time to time with effect from the date of her joining. Her appointment is subject to satisfactory verification of original certificates of age, caste, category, educational qualification issued by the competent authorities, medical fitness certificate issued by an authorized Government Doctor and subject to satisfactory verification of character and antecedents. **On such appointment she is attached to Balasore district. She will report before Supdt. of Police, Balasore by 21.06.2023 positively.** She will be deputed for undergoing Sub-Inspector of Police course of training in the next available batch.

Her appointment is purely temporary and can be terminated at any time without assigning any reason thereof.

She will execute a bond in P.M. Form No.106-A on joining in Balasore district.

She is liable to be discharged at any stage of her progress in monthly or periodical examination during Sub-Inspector course of training, if found unsatisfactory or she otherwise render himself undesirable.

She should be fit to attend parade and physical lessons during her training period. Any report from a Doctor declaring her unfit to undergo lessons for any length of time will make her liable for discharge from service.
