In pursuance of Odisha Police Recruitment Board letter No. 191/OPRB, dtd. 11.11.2022, the following selected candidates are appointed temporarily as Cadet Sub-Inspectors of Police in the Pay Band of Rs.9300-34800/- with Grade Pay-4200/- i.e. Rs. 35400/- in Cell-1 of Level-9 of Pay Matrix of ORSP-2017 with effect from the date of their joining for undergoing S.I's course of training at Biju Patnaik State Police Academy, Odisha, Bhubaneswar. Their appointment is subject to re-verification of original certificates of age, caste, category & educational qualification.

For candidates selected under Ex-serviceman and Sports Categories, their appointment is subject to satisfactory verification of their Ex-serviceman Certificate and Sports Certificate issued by the competent authorities.

The appointment is subject to submission of medical fitness certificate issued by an authorized Government Doctor. Further, the appointment is subject to satisfactory verification of their character and antecedent.

They shall be on probation for a period of two years from the dates of their joining or date of passing Final Examination of Sub- Inspector's course of training whichever is later in terms of Rule 22 of Home Deptt. Notification No. 4888/D&A dt. 05.02.2021.

They will report for training at **Biju Patnaik State Police Academy, Bhubaneswar on 28 / 12 /2022.**

Their appointment is purely temporary and can be terminated at any time without assigning any reason thereof.

They should execute a bond in P.M. Form No.106-A on their joining at Biju Patnaik State Police Academy, Bhubaneswar.

They are liable to be discharged at any stage of their training, if their progress in monthly or periodical assessment is found unsatisfactory or they otherwise render themselves undesirable.

They should be fit to attend parade and physical lessons throughout the year. Any report from a Doctor declaring any of the candidate unfit to undergo lessons for any length of time will make him/her liable for discharge from service.

Their inter-se-seniority in the rank of S.I of Police will be determined as per Home Deptt. Notification No. 4888/D&A dt. 05.02.2021.



4. The date of joining of each cadet S.I may please be intimated to this Headquarters early.


