In pursuance of Odisha Police Recruitment Board letter No.191/OPRB, dt.11.11.2022, the following selected candidates are appointed temporarily as Cadet Sub Inspector of Police (Armed) in the Pay Band of Rs.9300-34800/- with Grade Pay-4200/-i.e. Rs. 35400/- in Cell-1 of Level-9 of Pay Matrix of ORSP-2017 with effect from the date of their joining for undergoing Sub-Inspectors' of Police (Armed) course of training at Biju Patnaik State Police Academy (BPSPA), Bhubaneswar. Their appointment is subject to re-verification of original certificates of age, caste, category, educational qualification.

For candidates selected under Ex-serviceman and Sports Categories, their appointment is subject to satisfactory verification of their Ex-serviceman certificate and Sports Certificate issued by the competent authorities.

The appointment is subject to submission of medical fitness certificate issued by an authorized Government Doctor. Further, this appointment is subject to satisfactory verification of their character and antecedent.

They shall be on probation for a period of two years from the dates of their joining or date of passing Final Examination of Sub- Inspector (Armed) course of training whichever is later in terms of Rule 24 of Home Deptt. Notification No. 4576/D&A, dt.04.02.2021.

They will report at **Biju Patnaik State Police Academy, Odisha, Bhubaneswar** on **28.12.2022** for undergoing Sub-Inspectors' of Police (Armed) course of training.

Their appointment is purely temporary and can be terminated at any time without assigning any reason thereof.

The selected candidates appointed as Cadet S.I. of Police (Armed) will undergo Cadet Sub-Inspectors' of Police (Armed) course of training for a period of 15 (fifteen) months at Biju Patnaik State Police Academy (BPSPA), Bhubaneswar and such other training as decided from time to time.

They should execute a bond on their joining at Biju Patnaik State Police Academy (BPSPA), Bhubaneswar.

They are liable to be discharged at any stage of their training, if their progress in monthly or periodical assessment is found unsatisfactory or they otherwise render themselves undesirable.

They should be fit to attend parade and physical lessons throughout the year. Any report from a doctor declaring any of the candidates unfit to undergo lessons for any length of time will make him liable for being discharged from service.

Their inter-se-seniority in the rank of S.I. of Police (Armed) will be determined as per Home Department Notification No.4576/D&A, dtd.04.02.2021 and Notification No.31092/D&A dtd.03.09.2021.
