OFFICE ORDER NO. 274 /PERS.I DT. 26 02.2019

The case of C/773 Satya Narayan Patra of Ganjam district was taken into consideration by the Central Selection Board held on 01/02.07.2016 for promotion to officiate as ASI of Police and the findings of the CSB was kept in sealed cover due to pendency of Ganjam district proceeding No. 13/15. C/773 Satya Narayan Patra represented for consideration of his promotion to the rank of OASI as the major punishment of "One Black Mark" which was awarded to him in the above proceeding was reduced to "Censured in SB". The matter was placed before the DGP. As per orders of the DGP, the sealed cover was opened on 05.01.2019 and it is found that C/773 Satya Narayan Patra of Ganjam district has been selected by the above CSB.

In accordance with Govt. of Odisha, Home Deptt. Notification No.11400/D&A, dtd. 28.02.2009, C/773 Satya Narayan Patra of Ganjam district is hereby allowed to officiate as ASI of Police in Ganjam district. He will assume higher charge as OASI of Police from the date of his joining.

Pending passing the final training examination, he will not be entrusted with the duty to conduct any enquiry or investigation as per the provisions of the Cr. P.C during the officiating period as OASI of Police. On the basis of the result of the final examination, his inter-se-seniority in the rank of ASI shall be reckoned from the date of passing the final examination in ASI course of training. If he fails in the final examination, he will be allowed two more chances to clear the failed subjects. In the event of failure to clear the failed subjects in two successive attempts, he shall be reverted immediately to the substantive rank i.e the rank held prior to his officiating as ASI of Police. The annual increments shall not be allowed unless and until the aforesaid examination is passed by him.
