The Sepoys / Constables may be relieved to join their districts/ Estts. of posting. The Sepoys / Constables selected for reversion may be allowed two months' time for relief on their request, if the Sepoy / Constable fails to join the district/ Estts. of his posting even after two months, the Order of redeployment will be cancelled. Such persons will not be considered for redeployment for the next 3 (three) years. On joining the districts/ Estts. as Constable they shall undergo a 3 (three) months " Orientation Training Course" in Law and Rules at the District Headquarters. The District Supdts. of Police are requested to organize the training.

The dates of relief/joining of the Sepoys/Constables may be intimated to all concerned.
