Having been selected by the Central Selection Board held at State Police Hdqrs. on 05.12.2012 and in pursuance to Govt. of Odisha, Home Deptt. Notification No.11400/D&A dt. 28.02.2009, the following Constables who have passed the written examination of Constables to undergo the ASI's course of training held in the year 2000, 2002 and 2004 are allowed to officiate as ASI of Police in the Districts/ Establishments as noted against each, pending passing the final examination of ASI's Course of training. They will assume the higher charge of Officiating ASI of Police from the date of their joining. They will be deputed to undergo ASI's course of training for a period of four months comprising of one month institutional basic training at designated training institution and 3 months practical training in the Police Station and shall be required to pass the final examination to be conducted simultaneously in due course.

Pending passing the final training examination, they will not be entrusted with the duty to conduct any enquiry or investigation as per the provisions of the Cr. P.C. during the officiating period as Officiating ASI of Police. On the basis of the results of the final examination, their inter-se seniority will be determined according to the marks obtained by them in the final examination. In case if more candidates secure equal marks the names will be arranged according to their relative seniority in the feeder grade. Their seniority in the rank of A.S.I. shall be reckoned from the date of passing the final examination in A.S.I.'s course of training. If they fails in the final examination, they will be allowed two more chances to clear the failed subject(s). In the event of failure to clear the failed subject(s) in two successive attempts, he/ she shall be reverted to the substantive rank i.e. the rank held immediately prior to his/ her officiating as ASI. The annual increments shall not be allowed unless and until the aforesaid examination is passed by the Officiating A.S.I.


