ENGAGEMENT OF INSURANCE CONSULTANT

1. BACKGROUND.

The Odisha Police is committed to serve people of Odisha, which is eleventh largest state in India in terms of population with about 4.2 Crore Citizens. Currently the Sanction strength of Odisha Police is about 72,145 personnel. We want to take a Group Mediclaim policy for all the Odisha Police personnel along with their dependents.

2. TERMS OF REFERENCE (TOR) AND INSTRUCTION TO BIDDERS.

The Bidders or their authorized representatives will make it convenient to attend the bid opening. In case of unscheduled holiday on the closing/ opening day of the bid, the next working day will be treated as date of closing / opening.

3. VALIDITY PERIOD OF BID : 60 (sixty) days from the date of opening of bid.

In exceptional circumstances, the Owner may request all the Bidders to consent to an extension of the period of validity of their respective Bid. The request and the response thereto will be made in writing. Extension of validity period by the Bidder must be unconditional.

The offers received from eligible Firms will be evaluated for engagement as consultant for Odisha Police, as per the following procedure.

4. PRE-QUALIFICATION CRITERIA FOR SHORT LISTING:

- i) The Firm must have valid accreditation with the IRDAI & must have completed one year of service as on bid date.
- ii) The Firm must be registered with IRDAI for Direct / composite Broking. Documentary evidence to this effect is required to be submitted.
- iii) The agency must be presently in the empanelment list of minimum one SPSUs / State Govt. Undertaking.
- iv) The bidder must have the experience of handling Group Mediclaim Policy.
- v) They must have handled at least Rs. 20 Crores of premium in any of the last three financial years i.e 2015-16, 2016-17 & 2017-18.
- vi) The agency must have PAN Number and GST Registration Number. Copy of the same to be provided.
- vii) The agency must not have been black listed by any Govt. PSU/ IRDAI at any point of time.

5. **DURATION OF CONCLTANCY:**

The assignment will be valid for a period of three years.

6. **GENERAL TERMS AND CONDITIONS & BIDDING GUIDELINES:**

There will be no additional cost to ODISHA POLICE. The Bidders would be remunerated by insurance company of choice of the guidelines set down by insurance regulatory and development authority (IRDA). Any violation of rules and procedures as well as the tariff rate under TAC while quoting the item rate against each schedule of EOI documents shall solely be to the account of applicant.

Extension of Bid Submission / Bid Opening Date

All changes to the Bid document including any extension to the BID submission date will be made formally by insurance of an amendment to the EOI through the website. All Bidders must visit the website for the amendments before bid submission.

Bid Preparation and Submission

The Bidder shall provide all information sought under this EOI. Bidder shall submit the techno commercial Bid as per the formats provided as per **Annexure - 'A'** of this EOI. The owner will evaluate only those techno commercial Bids that are received in accordance with the format appended to this EOI. Bidder shall attach to its techno commercial Bid a signed copy of each amendment issued (if any) during the Bidding period. Guidelines mentioned below shall be used for submitting the Techno Commercial Bid.

The Bid must be submitted in the form of printed document. The Bidders must take all responsibility of submitting the Bids within the prescribed Bid submission Date.

7. **CRITERIA FOR SELECTION & EVALUATION OF EOIs:**

ODISHA POLICE will make the preliminary scrutiny of all the application /bids based on the qualifying eligibility criteria. Bidders not meeting any of the qualifying eligibility criteria and other essential condition mentioned in the EOI document will be summarily rejected. After scrutinizing of all applications, eligibility criteria and other relevant documents, The ODISHA POLICE will evaluate the bids of those bidders who meet the eligibility criteria stipulated in the EOI.

One agency will be selected for engagement as insurance Consultant /Broker of ODISHA POLICE on the basis of above evaluation .The evaluation the qualifying BIDS will be based on a 100- point scale as per the Annexure.

ODISHA POLICE reserve the right to cancel the EOI without assigning any region what so ever. ODISHA POLICE also reserve the right to modify the terms and conditions of the order.

8. **REJECTION OF EOI / BID DOCUMENTS:**

Establishment reserves the right to accept or reject any Bid /all Bids at any time prior to contact award, without assigning any reasons thereof and Owner shall not entertain any claim whatsoever on this account. The Bidder shall have no claim on owner in case his Bid is rejected, or the bidding process is annulled.
