

The sanction orders are being issued separately. Besides, the copies of R.C. invoice & insurance are required to be submitted to the sanctioning authority within 03 Months, failing of which shall be recovered the total advance amount from the loanee.

Loanee may purchase EMV worth value more than sanction amount(75% of invoice submitted)but not less than the sanction amount, if the Electric Vehicle cost at the time of purchase is less than cost in Electric Vehicle proforma invoice submitted along with application, then differential cost between 75% of the purchase cost and 75% of proforma invoice, will be recovered along with interest from the loanee.


