dt.4.10.02 relating to prevention and detection of forcible  
collection of 'Chanda' on festive occasions by anti-social  
elements in the State. Despite above orders/circulars,  
instances of lawlessness/confrontation over forcible collection  
of subscriptions (Chanda) in different Basti/Markets and on the  
National Highways/other important routes from drivers of buses/  
trucks have been reported. Consequently, some conscious  
citizens have filed a PIL in the Hon'ble High Court, Orissa,  
alleging failure of the State Administration in combating such  
crimes. You are aware that such collection of 'Chanda' is a  
social evil and invites action U/s 384/385/386/387/392 and 394  
IPC etc. As such it is reiterated that the IICs/OsIC of PSs/  
OPs of your district may please be suitably instructed to  
ensure strict implementations of the orders issued earlier  
from this end from time to time in order to check such social  
evil on the NH/SIH, particularly on the eve of festive occasions  
such as, Dashara, Gajalaxmipuja, Kalipuja, Ganeshpuja and local  
festivals.
