AMENDMENT OF POLICE CIRCULAR ORDER NO.341/2013.

Govt. of Odisha Home Department, Bhubaneswar have formulated the Odisha Battalion Service {Method of Recruitment and Conditions of Service of Sepoys or Constables, Havildars and ASI (Armed)} Order, 2022 communicated vide Home Department Notification No.30941/D&A, Dtd.13.09.2022 published in Odisha Gazette No. 2697, Dtd. 19.09.2022.

In the above mentioned order, Provision of Change of Cadre of Sepoys/ Constables of Battalions from one Battalion to another Battalion has been prescribed under Appendix-A of the said order.

Keeping in view of the above provision in the Recruitment Rules for Change of Cadre, following amendment to Police Circular Order No.341/2013 is hereby ordered.

- 1. Para "B" of the Police Circular Order No.341/2013 under the heading "DEPLOYMENT FROM ONE BATTALION TO ANOTHER BATTALION" is hereby repealed.
- 2. Para "C" of the Police Circular Order No.341/2013 under the heading "TRANSFER ON DEPUTATION FROM ONE BATTALION TO ANOTHER BATTALION ON MARRIAGE" is hereby repealed.
- 3. Form "A" and "B" as annexed to the Police Circular Order No.341/2013 are hereby repealed.

This amendment order is issued herewith immediate effect.

AMENDMENT TO POLICE CIRCULAR ORDER NO. 341/2013.

PCO 341/2013 and PCO 342/2013 were formulated to regulate deputation of Constables/Sepoys to deputationist organization as well as cadre change of Constables/Sepoys from one district to another district or from one Battalion to another Battalion.

On reexamination, it was felt that cadre change should be as per recruitment rules, which is formulated by the Government.

Accordingly for district constables, Government was moved for modification of Recruitment Rules to permit cadre change and Government of Odisha accordingly formulated "The Odisha Police Service (Method of Recruitment and Conditions of Service of Constables) Order, 2021 communicated vide Home Department Notification No.31202/D&A, dtd.04.09.2021, which contained a scheme of cadre change. Accordingly, the Cadre change of Constables of district police has been done this year in accordance with the new RR cited above and Para-B and Para-C of the Police Circular Order of 342/2013 dealing with cadre change were repealed.

State Police Headquarters has sent similar proposal to Government to incorporate cadre change in the recruitment rules of OSAP Sepoys/Constables also. This is under consideration of the Government. Hence, change of cadre as detailed in Para-B and Para-C of Police Circular No.342/2013 is hereby kept in abeyance. Change of cadre would be taken up once the approval of the Government for the same is received

In order to utilise the rich experience of Odisha Police Personnel returning on repatriation from Special protection Group(SPG) and National Security Guard(NSG) or any other security related Organisation(s) of Government of India after successful completion of their deputation tenure, the following amendments in the Police Circular orders No. 337/2013, 341/2013, 342/2013 and 347, 2013 are hereby Ordered.

POLICE CIRCULAR ORDER No.341 / 2013 WITH AMENDMENT DATED.05.09.2013

The provision relating to deployment of Sepoys/Constables is hereby amended and the revised PCO 341/2013 with amendment is as follows:

As per Government Notification No 15082/D&A, dtd. 22.03.2011, the posts of Sepoys/Constables in each Battalion shall constitute a separate cadre. The incumbents may be deployed to any Battalion, Police Establishment or offices for periods not exceeding 7 years at a time in exigency of public service or for administrative reasons or otherwise without any change of their position in the cadre to which they belong.Such deployment beyond 7 years for an incumbent may be allowed in the exigency of public service by the DG & IG of Police.

In order to streamline the deployment process the following guidelines are to be followed

A. DEPLOYMENT ON DEPUTATION FROM ONE BATTALION TO ANOTHER DEPUTATIONIST ORGANISATION.

1. Sepoys/Constables of one Battalion will become eligible for deployment (on deputation) to other deputationist Establishment after completion of 7 years of service as on 1stday of January of that year in the parent Battalion.

2. The period of deployment (on deputation) will be for a period upto 3 years and can be extended up to 7 years in phases.

3. A Sepoy/Constable will not be considered for a second or subsequent deputation unless he serves an equivalent period of his first deputation in his parent cadre.

4. The above principles videSl No. 1, 2 and 3 will not be applicable for deployment (on deputation) to the Sepoys/Constables for posting to SOG/SIW Organization. Any Police personnel can be deployed on deputation to SOG/SIW irrespective of his duration of service.

5. After completion of the deployment (on deputation) period, they should be repatriated back to the parent cadre without waiting for further order. The deputationist organisation can also repatriate prematurely under intimation to SP HQRS if the person is involved in criminal case or the performance is found not satisfactory.

B. DEPLOYMENT FROM ONE BATTALION TO ANOTHER BATTALION.

Continuation on deployment (on transfer) in a different Battalion is causing dislocation in public service due to large number of vacancies in the Battalion from where large number of Sepoys/Constables are transferred on deployment. Hence it is decided to absorb them in new cadre. The following guidelines will be followed: 1. No Sepoy/Constable will be deployed to another Battalion irrespective of any ground/ administrative requirement/ representation.

2. Sepoys/Constables will be absorbed in a new cadre(Battalion) on the following principles:

- (i) He has to complete 8 years of service as on 1stday of January of the year in which he is to be absorbed.
- (ii) He must have worked for 6 years in the parent cadre and SOG/ SIW in case of Sepoys/Constables served in SOG/ SIW.
- (iii) He should have good service record.
- (iv) Not more than 15% of the vacancies of a year as on 1stday of January in the cadre can be filled up through absorption into the cadre.
- (v) Rule 11(4) of G.A. Department Notification No. 22591/Gen dtd.16.10.85 of Odisha Ministerial Services (method of Recruitment to the posts of Junior Clerk in the district offices) Rules'1985 says that Jr. Clerk of district cadre who wants transfer on deputation i.e., he shall upon such transfer forfeit his/ her seniority for his/ her past service and shall in the seniority list in relation to the year in which he/she is transferred rank below the junior most junior clerk to the district to which he/she transferred.

3.Sepoy/Constable of a Battalion is also a Battalion cadre, hence the above principle is also applicable to them.

- (i) The Sepoy/Constable will apply through his cadre controlling authority in **Form-A**.
- (ii) His seniority in the new cadre (in which he is absorbed) will be counted from the date of joining the new cadre. Qualifying service required for promotion to the rank of Lance Naik, Havildar, Havildar Major, SI(Armed) will be counted from the date of joining in the new cadre and any test passed in the old cadre won't be counted for promotion to the rank of Lance Naik, Havildar, Havildar Major, SI(Armed) in the new cadre.
- (iii) When two or more join a Battalion in a particular year on transfer the inter se seniority of such Sepoy/Constable shall be determined taking into account the period of service rendered by them prior to such transfer.

(iv) The last pay drawn by the Sepoy/Constable shall be protected and his normal date of annual increment remain unchanged without prejudice to the operation of any other rule applicable to him.

- Views of cadre controlling authority of the cadre in which he will be absorbed will be taken.
- (vi) Change of cadre is the discretion of the competent authority and cannot be claimed as matter of right and any personnel absorbed in a new cadre can be repatriated back to his parent cadre at the discretion of competent authority.
- C. TRANSFER ON DEPUTATION FROM ONE BATTALION TO ANOTHER BATTALION ON MARRIAGE.

In case of a Sepoy/Constable whose spouse is also serving as a Constable in a different cadre, he can apply for a change of cadre to different Battalion.

i) His seniority in the new cadre (in which he is absorbed) will be counted from the date of joining the new cadre. Qualifying service required for promotion for the post of Lance Naik, Havildar, Havildar Major, SI(Armed) will be counted from the date of joining the new cadre and any test passed in the old cadre won't be counted for promotion to the rank of Lance Naik, Havildar, Havildar, Major, SI(Armed) in the new cadre.

 The Sepoy/Constable will apply through his cadre controlling authority in FORM-B.

iii) Views of cadre controlling authority of the cadre in which he will be absorbed will be taken.
