POLICE CIRCULAR ORDER NO. 376/2018

SUB:- Timely compliance to direction of Hon'ble High Court of Orissa and Supreme Court of India.

It is seen that sometimes the field functionaries i.e SsP and IsIC are not complying with the instructions issued by Hon'ble High Court of Orissa and Hon'ble Supreme Court of India in time . In CRLMP No. 1320 of 2015 the Hon'ble High Court has expressed sheer displeasure for repeated non-compliance of orders given in the matter of submission of PWC/case diaries/instructions/status report etc. In some cases CRLMPs have been filed for non-registration of FIR, inaction of police in arrest of accused, delay in investigation and non-execution of NBWs. The respective SsP and IsIC have not complied with the instructions/orders of the Hon'ble High Court even after issuance of repeated reminders from the office of A.G., Odisha, Cuttack. In spite of several PCOs and instructions issued earlier in this regard, the district SsP as well as field functionaries are not understanding the gravity of urgent court matters for which the cases are delayed.

Now in order to avert recurrence of such lapses in future, the following instructions are hereby issued which must be implemented strictly in letter and spirit.

1. All district SsP / DCsP/ SsRP shall issue suitable instructions promptly to all field functionaries for timely compliance of orders of Hon'ble High Court of Orissa on priority basis.
2. The DSP (Crime) of the district be appointed as a nodal officer to follow up all the High Court matters on daily basis and he shall be responsible for timely compliance of the directions and orders issued by Hon'ble High Court and Hon'ble Supreme Court of India.
3. The nodal officer shall check the e-mails daily and download the communication from the office of the Advocate General and transmit the



- instructions to field functionaries and ensure the compliance of all directions given by Hon'ble High Court timely.
4. The nodal officer shall maintain a register / data base regarding all the communications received from A.G, Odisha/ CID, CB and ensure time-bound compliance.
  5. The nodal officer shall put up the register twice every week before the concerned SP for his monitoring and follow up action.
  6. The nodal officer shall remain in touch with concerned Addl Govt Advocates /Addl. Standing Counsels and coordinate for timely response from respective quarters and filing of counter affidavits, instructions, reply on show cause and time petitions etc. after due discussion with concerned law officer of the office of Advocate General Odisha, Cuttack.
  7. The phone numbers and e-mail IDs of all IsIC/OsIC and the nodal officers shall be furnished to the office of Advocate General Odisha Cuttack and CID, CB for quick communication. This may be updated quarterly by SsP / DCsP/ SsRP .
  8. All district SsP / DCsP/ SsRP will personally ensure that above mentioned instructions are complied strictly and any lapses are dealt with severely.

Deviation of the instruction shall be viewed seriously and it is made imperative to take action against the erring officials.
