

POLICE ORDER No. 151

Revised

Consequent upon the separation of the Police Motor Transport from the Police Radio Grid, with effect from the 1st May 1955 in Government Order No. 665-Reforms, dated the 18th June 1955 and the resultant change in the designation of the Superintendent of Police, Transport & Signals to Superintendent of Police, Signals, the following revised distribution of duties between the Superintendent of Police, Signals, Orissa, Cuttack and the Superintendents of Police, Districts/Units for the administration of the Police Radio Grid and the Carrier Pigeon Service are made in cancellation of Police Order No. 2 of 1949.

B. CARRIER PIGEON SERVICE .

The Pigeon S.-I, will continue to be placed under the administrative control of the Superintendent of Police, Signals who will be responsible for the training and efficiency of the Carrier Pigeon Service.

(The S.P., Signals will exercise his powers of punishment on the Pigeon Constables through Superintendents of Police Districts).

(6) Pigeon registers will continue to be maintained in the District Reserve Office under the supervision and inspection of the Pigeon S.-I. and the S.P., Signals.

It should be the endeavour of the S.P., Signals to work in harmony and close co-operation with the Superintendents of Police, District Units. If, however any difference of opinion arises between the S.P., Signals and the Superintendent of Police or any District/Unit, the matter will be referred to the D.I.-G., Technical for decision.

C. SIGNALLING STAFF OF THE O. M. P. BATTALIONS AND THE DISTRICT POLICE

The Signalling Staff of the O. M. P., Battalions and the Helio Signalling Staff of Ganjam and Koraput districts will continue to be under their respective Commandants and Superintendents of Police but their work and training will continue to be inspected and supervised by the S. P., Signals.
