POLICE ORDER No. 297/1996

RECRUITMENT OF SEPOYS IN O.S.A.P. BATTALIONS

In modification of previous Police Orders/Circulars, the following procedure is outlined for recruitment of Sepoys in the O. S. A. P. Battalions except for O. S. A. P., 2nd Battalion.

1. SELECTION BOARD

(a) The recruitment shall be conducted by Selection Board of Officers consisting of the followings:—

(b) The Director General and Inspector-General of Police, for any reason, may form a Special Selection Board for recruitment of Sepoys of any of the Battalions, if so desires.

2. ELIGIBILITY

(a) A candidate must be an inhabitant of the State of Orissa and must have registered his name in any of the Employment Exchanges of the State.

(b) A candidate must have passed H. S. C. or equivalent examination from a recognised Institution

(c) A candidate must have passed ORIYA a one of subjects in H. S. C. of must have passed Oriya in M. E. Standard. Candidates belonging S.C./S.T. categories must have passed Class IX. However S.C./S.T. candidates who have passed H. S. C. will be preferred.

3. AGE

The age of the candidate must be between 18—25 years for General Candidates. The upper age limit is relaxable in case of S.C./S.T. and O. B. C. candidates as may be decided by Government from time to time.

(b) Women Candidates are not eligible for recruitment a Sepoy in O.S.A.P. Battalions.

* Recommendation of the N. P. C. in fifth report (Chapter XLIII) "43-14. The Selection Board should consist of D. I.-G. as the Chairman assisted by a Superintendent of Police in-charge of an Armed Police Battalion and Superintendent of Police from one of the districts."

4. RESERVATION OF VACANCIES

The existing rules and orders regarding reservation of posts in services prescribed by the State Government from time to time for S.C./S.T. Sports Men, Ex-Service men and for Socially and Educationally Backward Class should be strictly followed while recruiting Sepoys. The Selection Board should take adequate care to see that the percentage in the recruitment is maintained as per the Model Roster (Revised). In the event of non-availability of S.C./S.T. Candidates, the concerned Commandant will make the State Police Hdqrs. for locating them by way of holding Special Drive for filling up the reserved vacante. On no account, appointing authority shall fill up the reserved vacancies for S.C./S.T. by way of exchange or otherwise without prior approval of D. G. and I-G. of Police.

5. AWARD OF MARKS

15 Marks each will be awarded to candidates for educational qualification and physical standard in height as prescribed below:—

No candidate should be kept in the waiting list.
