POLICE ORDER No. 30

Duties and powers of the Deputy Inspector-General of Police, Orissa. Government have been pleased to authorise the Deputy Inspector-General of Police, Orissa, to perform the duties and exercise the powers enumerated below:—

- 1. To ensure the efficiency of all branches of Police work, by conducting inspections at the headquarters and in the interior of districts and by maintaining close touch with Superintendents and District Magistrates.
- 2. To examine the tour diaries of Superintendents before they are submitted to the Inspector-General (P. M. Rule 45).
- 3. To pass Sub-Inspector after training and to confirm them or extend their probation or discharge them (P. M. Rules 681 and 682).
 - 4. To exempt Constables from training in suitable cases [P. M. Rules 684(c)]
 - 5. To countersign the travelling allowance bills of Superintendents (P. M. Rule 755)
- 6. To transfer officers and men of and below the rank of Sergeants-Major from one district to another.
- 7. To grant leave to Sergeants-Major, Inspector and Sergeants subject to the restrictions laidl down in column 3 against item 15 of Appendix I of the Orissa Service Code [P. M. Rule 786 (a)].
- 8. To impose on any Police Officer below the rank of D. S. P. any one or more of the punishments in P. M. Rule 824 except dismissal or removal in the case of a Sergeant-Major or an Inspector (P. M. Rule 825).
 - 9. In partial modification of P. M. Rule 851 (b), there shall be one appeal in each case as follows:—

Against an order passed by a Superintendent, to the D. I.-G., against an original order passed by the D. I.-G. to the I.-G. against an original orider passed by the I.-G. to the Provincial Government.

- 10. To call for the proceeding in any case, even where no appeal lies, and refer them to the I.-G. for orders (P. M. Rule 853).
- 11. To sanction rewards up to Rs. 200 in any one case (P. M. Rule 857)
- 12. To pass orders on reports regarding loss or damage arms and ammunition (P. M. Rule 1107).
- 13. To make temporary changes not exceeding one year in duration in the district staff
- 14. To examine proposals for alterations in the jurisdictions and sites of Police posts on receipts from Superintendents through the District Magistrates.
- 15. To examine quarterly crime reviews and returns (P. M. Rule 323)
- 16. To persue and pass orders on special reports relating to items 8, 23, 24, and 29 of P. M. Appendix 3.
- 17. The Deputy Inspector-General shall also perform any other work specially delegated to him by the Inspector-General and shall be specially responsible for the emergency Police Force, the Training Schools, the Railway Security Force and the Fire Service.
