

**POLICE ORDER No. 76**

Orissa Police Sports Fund. The annual grant which Government makes for the athletic clubs in the Police Department is entirely distributed amongst the districts. O.M.P. Battalions, P.T.C., C.I.D., G.R.P., and Transport and Signals. No. part of this grant is utilised for the Central Sports Fund. This grant however is very insufficient to meet the requirement for the physical and athletic development in the Police force. It is therefore, necessary to augment the Government grant in the districts and establishment and also to build up a Central Fund for financing the State Police meetings for games, sports and athletics. The field for athletic competition and for games such as hockey and football have been extended for competition amongst the State on an all India basis. This also places a very heavy strain on the Central Fund. In order to take part in all-India competitions it is essential that facilities for training and practice be given to the participants and this can only be financed from the Central Sports Fund.

2. To augment the district funds and also to build up the Central Fund, annual subscription in two equal instalments will be collected in the months of January and July. The rates of annual subscriptions are as follows:—

3.(a) The Sports Committee have unanimously decided that the minimum annual contributions from the districts and establishments will be as noted below. This is based on the strength of the force and the bi-annual rates of contributions which the districts and establishments are making to the Central Fund. The amount specified against each district or establishments shall be sent in two equal instalments by the 1st of February and 1st of August each year from the contributions collected in the months of January and July.

(b) The contributions will be sent to the Secretary, Orissa Police Sports Fund, Cuttack.

4. The District Sports Fund shall be used for the promotion of games, sports and athletics at district headquarters and as far as possible, at police-stations, subdivisional headquarter so that men at the Muffassil stations get some benefit from the fund. The district fund will be administered by a Committee which should include the Superintendent of Police/Commandant as President, the Sergeant-Major as Secretary and one representative from each of the other ranks who should be nominated by the President on each occasion when it is necessary to hold a meeting.

5. The Central Fund will be earmarked for the promotion of inter-district/ unit competition in games, sports, and athletics, boxing and such other activities as the Central Committee may from time to time consider necessary and for Inter-State Police Competitions. The Secretary will be responsible for administering the fund on behalf of the Central Sports Committee.

6. This Police Orders cancels Police Order 6 of 1936 and any other circulars in this connection which may have been issued prior to this Police Order.
