

POLICE ORDER No. 150

Expert examinations of exhibits relation crime. In spite of instructions laid down in the Police Manual and Circulars issued from time to time, regarding sending of exhibits relating to crime, for experts examination, it is noticed that exhibits are often missent or references are made to know whether to send particular exhibits for expert examination. A chart showing where to exhibits for expert examination should be sent with references to the relevant P.M. Rules and Circulars, is appended herewith. A copy of this charts should be kept in every police-station and police office for ready reference.

and sex of the victim, (v) Soft tissues and biological fluids for determination of origin, (vi) Breast-milk for chemical and microscopical examination in connection with suspected abortion cases, (vii) Suspected substances, e. g., remnants of food or any medicine suspected to have been administered, vessels in which poison is suspected to have been powdered or stored before its administration, (viii) Suspected acid or other drug stained articles, (ix) Blood and blood stained articles, (x) Semen and semen stained articles, (xi) Hairs for the determination of origin, site etc. and for comparison, (xii) Swabs and smears in connection with sexual offence cases.
