Having considered all the objections, the D.G. & I.G. of Police, Odisha, Cuttack shall furnish the draft Final Gradation List of OAPS Group-A (Senior Branch) Officers i.e. in the rank of Deputy Commandant with his specific views on the objections received, for preparation and publication of the final Gradation List as per catch up principle.
