No.29320—DP-PERII-APPT-0015/2021-HOME.— In exercise of the powers conferred by Section 2 of the Police Act, 1861 (Act No. 5 of 1861) the State Government do hereby make the following orders to amend the Odisha Police Signals Service (Method of Recruitment and Conditions of Service) Order, 2021, namely:—

1. Short title and commencement: (1) These orders may be called the Odisha Police Signals Service (Method of Recruitment and Conditions of Service) Amendment Orders, 2021.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Odisha Police Signals Service (Method of Recruitment and Conditions of Service) Order, 2021 (hereinafter referred to as the said order), order 7, in clause (1),—

(i) for sub-clause (c), the following sub-clause shall be substituted, namely: —

"(c) have passed B.Sc. in Computer Science or Information Technology or Information Science and Technology or Electronics & Telecommunications or Information Technology and Management or Electronics Science or Physics or Mathematics or Statistics or Electronics or allied subjects or Bachelor in Computer Application (BCA) from a recognized University or Bachelor Degree in Engineering or Computer Science or Information Technology or Electronics and Communication or Electrical or Electronics or Instrumentation or allied subjects from a recognised University ;

- (ii) the sub-clause(d) shall be omitted ; and
- (iii) for sub-clause (e), the following sub-clause shall be substituted, namely: —

"(e) have Odia language as one of the subjects in the High School Certificate Examination or passed an examination in Odia Language equivalent to M.E. standard recognized or conducted by the School & Mass Education Department, Government of Odisha."

3. In the said order, for order 8, the following order shall be substituted, namely: —

"8. The Scheme of Examination: (1) The scheme of examination for direct recruitment shall comprise of —

- (i) Written examination in three papers, as follows : —

- (a) PAPER-I (General English & Odia Language) (Qualifying in Nature)
- (b) PAPER-II (Quantitative Aptitude and Reasoning Test) and
- (c) PAPER-III (Computer Test);

- (ii) Computer Skill Test; and

- (iii) Physical Efficiency Test (Qualifying in Nature).

(2) The subject, syllabus and the standard of examination for direct recruitment shall be as specified in Appendix-'A' appended to this order".

4. In the said order, for order 9, the following shall be substituted, namely: —

"9. Merit List: (1) The Merit List shall be prepared by the Board as per reservation category wise of the candidates who have qualified in the Written Tests, Computer Skill Test, Physical Efficiency Test and based on the aggregate marks obtained by candidates in Paper- II (Quantitative aptitude and Reasoning), Paper- III (Computer Test), Computer Skill Test and marks for NCC Certificates.

(2) The merit list shall remain in force for a period of one year from the date of publication for general information or until fresh merit lists are prepared by the Board, whichever is earlier."

5. In the said order, in Appendix-A, —

- (i) in clause 1, for the second para., after the table, the words beginning with "There shall be one paper" ending with the words and figures "Computer Skill Test(Practical) 50 Marks-60 minutes", the following para. shall be substituted, namely: —

"There shall be one paper in General English and Odia language which will be qualifying in nature. The candidates have to secure atleast 50% marks for

qualifying for same paper. The Board shall prepare a list of candidates equal to three times, the vacancies advertised for appearing in the Computer Skill Test and Physical Efficiency Test from the candidates who have qualified in General English and Odia Language based on the combines marks secured by them in (Quantitative Aptitude and Reasoning Test) and (Computer Test).".

(ii) in clause 2, for sub-clauses (3) and (4), the following sub-clauses shall be substituted, namely: —

“(3) Computer Test (Written) : The paper will include questions covering the following, subjects, namely: —

- (i) Basics of Computer and Information Technology;
- (ii) Fundamentals of Operating Systems like Windows, Linux, etc.;
- (iii) Office Automation Softwares like M.S. Office, G-Suite, etc.;
- (iv) Fundamentals of data communications and networking;
- (v) Network protocols and Security;
- (vi) Web Designing, E-Commerce, Internet;
- (vii) Database Management Systems;
- (viii) Application development —PHP-Javascript-HTML;
- (ix) Programming and Problem solving through ‘C’ language, Java, Android Programming and Python;
- (x) Introduction to (Multimedia and Photoshop); and
- (xi) Basic Concepts of Electronics and Telecommunications.

(4) Computer Skill Test (Practical)- 50 Marks- 60 Minutes:

The Computer Skill Test will test the practical Computer Skills in the following areas, namely: —

- (i) Operating System—Windows, Linux;
- (ii) Office Automation Packages like MS Excel Spreadsheet, Power point, MS Access, G-Suite ;
- (iii) Programming Skills in ‘C’ language, C++ language; and
- (iv) Application development using Java/ PHP, Java Script,HTML/CSS.".
