HOME-SPS-PMTN-0004-2023- 2451 /SPS. Sri Belar Meher, OAPS is promoted to the grade of OAPS Group-A (Senior Branch) i.e. to the rank of Deputy Commandant of Police of the O.A.P.S. Cadre in the scale of pay of Rs.67,700 - 2,08,700/- in level-13 in the Pay Matrix under ORSP Rules, 2017 per month on ad-hoc basis for a period of one year from the date he actually joins in the promotional post or till the recommendation of the O.P.S.C. is received and accepted by the Government whichever is earlier.

2. The posting order of the above promoted officer, if not on deputation, will be issued by the D.G. & I.G. of Police, Odisha, Cuttack under the powers delegated to him vide Home Department Notification No.18407.D&A dated 06/04/2007. The posting order of the Officer, if working on deputation, may be issued only after his reversion to the parent cadre.

3. If the Officer is currently on deputation to other Department/Organization may revert back to his parent cadre to avail the promotion. In case he is not provided the higher grade by the Department / Organizations he is working for, if he does not represent in writing, through proper channel, for his reversion he shall continue to work in his Department / Organizations in the same grade and he shall have no claim to higher grade and pay till his reversion to parent cadre.
